Sir,

I, Smt. Kanika Barman, D/o. Pravat Barman & W/o. Sri. Premananda Roy, resident of vill- Bara Lachka Jote, P.O. New Rangia, Darjeeling-734012, would like to state that I am the FPS dealer of Ord Tea Garden, FPS Code:- WB0327809375, vill- M.M Terai, P.O. Belgachi, G.P. Upper Bagdogra of Naxalbari Block, Siliguri Sub-Division, Dist. Darjeeling, and under your Police Station jurisdiction.

On 29/11/2023, in the evening at 7:30 pm near about, at the time of unloading of ration articles by my tagged distributor at my FPS Shop of ORD Tea garden, the aforesaid miscreant Amal Singh entered into my FPS and stopped the unloading process. I raised my voice and asked him who has given him the right to stop the unloading process of my FPS. All of sudden Amal Singh attacked on me and started molesting me and attempted to rape me & toured out my wearing (clothes) in front of my husband Sri. Premananda Roy, S/o. Late. Nalinikanta Roy, Vill- Tarabari Jote, P.O. Rangapani, P.S. Bagdogra, Dist. Darjeeling. At same time my husband Sri. Premananda Roy has protested strongly to protect me and tried to stop the criminal Amal Singh but he started punching, kicking and beating my husband with his leather belt badly. In that pain and critical condition both of us me and my husband cried for help loudly. The said Amal Singh has warned me and my husband to kill us and our family and to face fatal consequences if we register any kind of FIR before any Police Station and disclose this matter to anyone.

We, both husband and wife are deeply injured and are in pain and had to rush to the doctor for treatment at Siliguri District Hospital, Darjeeling. I am living at high life risk with my family. Therefore, for your act of kindness I praying to register this FIR against the said Amal Singh for his aforesaid illegal act and committed crime. I have deep believed in law & order of my country and it has always taken suitable and strict legal actions against the criminal like Amal Singh to protect the honour of women citizen and our lives.
