I, **Suraj Chhetri** S/O Sri Shyam Singh Chhetri, resident of Rabindra Nagar, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, beg to report you that today i.e. **01.12.2023** at about **3.00 p.m.** when I was at Putimari with my friends then one **1. Krishna Sarki** S/O Smt. Sushila Sarki, **2. Narendra Rai** S/O Pratap Rai both are resident of Behind Upper Bagdogra Gram Panchayat, Lala Basti, Upper Bagdogra, Dist. Darjeeling, and **3. Sourav Ghosh** S/O Unknown, resident of Behind Milani Club, Gossainpur, P.O. & P.S. Bagdogra, Dist. Darjeeling who were fully drunk came there along with their friends and suddenly intercepted me and abused me in filthy language without and rhyme or reason or without any provocation. That when I asked them about the matter as to why they are behaving like this then they attacked me with knife with an intention to kill me for which I received grave and serious injuries in both my hands which resulted in serious bleeding from both my hands as a result I am suffering from severe pain.

The complained persons also snatched Rs. 60,000/- (Rupees Sixty Thousand) only in cash from my pocket which was the money of my owner which I had collected and was meant to be paid to my owner.

That the complained persons thereafter went to my residence and mishandled my wife Smt. Rina Chhetri and touched her inappropriately and threatened her with dire consequences. That they were on my lookout with an intention to kill me.

That thereafter as I was wounded I was taken to Bagdogra P.H.C. by my friends and the doctor after examining me put bandage over my wounds and thereafter released me with advice to take rest. (Copy Attached)
