Sir,

This is for your perusal that I Shyamashree Barma W/o, Sandip Barma, residing at Shaktigarh, P.S- New Jalpaiguri, Word no.-31, Dist- Jalpaiguri, like to draw your kind attention that today at about 10:30 p.m when I along with my husband namely Sandip Barma returning home after attaining a marriage reception at that time near Shaktigarh Ujwal Sanghya, some miscreants namely 1) Mithun Das @ Abhishek Das, S/o, Madhusudan Das, residing at Shaktigarh, P.S- New Jalpaiguri, Word no.-31, Dist- Jalpaiguri 2) Pabitra Ghosh (Bura), S/o- unknown, residing at Shaktigarh, P.S- New Jalpaiguri, Word no.-31, Dist- Jalpaiguri 3) Goutam Das (Chottu), S/o- Unknown, residing at Shaktigarh, P.S- New Jalpaiguri, Word no.-31, Dist- Jalpaiguri 4) Kaushik Das (Lob) residing at Shaktigarh, P.S- New Jalpaiguri, Word no.-31, Dist- Jalpaiguri & their associates restrains us & demanding money in drunken condition Rs- 10,000/-. When we refused to give the money they became fuming and started to assault my husband brutally with intention to kill him with iron rods and Dagger. As a result of that my husband Sandip Barma sustained grievous injury on his head & person. At that time the miscreants outrage my modesty by way of pulling my saree, blouse. They also snatched my gold chain & purse. During that moment I started hue & cry & subsequently few local people came out from their house. After watching the gathering the above named miscreants fled away from the place & some of the peoples take us to the nearest medicine centre. After preliminary fasted everyone suggested us to go to the nearest hospital. At present we are in a fear that the above named miscreants may take further attack on us.

Considering the above situation please take appropriate legal action against the above named miscreants & their associates according to law & obliged me.
