I, Sri Subrata Tarafder, S/o Late Samar Tarafder, resident of Lake Town, Ward No. 33 of Siliguri Municipal Corporation, P.O. Bhaktinagar, P.S. New Japaiguri, District Jalpaiguri, would like to inform you and report you the following:

That by a written complaint dated 15.09.2023 vide GDE No.621 at your Police Station I have already informed you that one Sarian Roy @ Pokhan Roy, S/o Late Alan Roy, resident of near Sahudangi High School, Sahudangi, under P.S. New Jalpaiguri, Dist. Jalpaiguri along with his some associates are constantly making efforts to unlawfully enter and occupy my lawfully purchased land as described in the schedule below. Thereafter I have also filed a civil suit being Title Suit No.597/2023 in the Court of the Ld. Civil Judge (Junior Division) at Jalpaiguri and simultaneously I have also filed an application under Order 39 Rule 1 & 2 of the Civil Procedure Code, 1908 before the said Ld. Court praying injunction upon said Sarian Roy @ Pokhan Roy and his associates in respect of the below scheduled land.

That on perusal of my said injunction application the said Ld.
