With due respect, I am producing herewith 01 (one) arrested accused person named Sanjay Dutta (29), S/o- Subhash Ch. Dutta of Jiban Adhar Apartment, Meghnath Sarani, Laketown, W/No. 33, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 01 (one) packet Sri Krishna Golden Ceremony (3 pcs).
2. 02 (two) packets Jawan Electric sparkles containing 10 (ten) packets in each.
3. 02 (two) packets Puja Big spinner containing 04 (four) packets in each.
4. 02 (two) packets Dhruvatar Akash Ganga super light.
5. 02 (two) packets Paanch Awatar Cornation.
6. 01 (one) packet Supreme Grape Nuts.
7. 02 (two) packets Kuil Colour Sparkles containing 08 (eight) packets in each.
8. 01 (one) packet Chakkar Special containing 05 (five) packets.
9. 03 (three) packets Puja Chutput.

I, SI Shib Sankar Das, presently attached with NJP PS, SPC under your kind control beg to state that on 08.11.2023, at about 18.30 hrs received a secret source information that one person as noted above is selling fire crackers illegally in his shop styled as 'Gift Shop' located at Gate Bazar, PS- NJP, Dist- JPG. Accordingly, I inform the matter to you and as per your kind direction at 18.35 hrs, myself along with ASI Dhruva Mishra, C/1044 Hari Kherwar, CV/306 Biswajit Roy all of NJP PS, SPC left for Gate Bazar information in hand Ref. NJP PS GDE No. 374, Dated- 08.11.23. At 18.45 hrs we arrived at Gate Bazar in the shop of Sanjay Dutta styled as 'Gift Shop' and as per indication by the source, found that the said person was selling fire crackers illegally. On being search his shop, found the above noted fire crackers were stored inside the shop. On demand he failed to produce any documents/license in respect of store/sale of the fire crackers which were recovered from his possession. Accordingly, I seized the above noted fire crackers which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18.55 hrs to 19.35 hrs on 08.11.2023. The total weight of the seized fire crackers is

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Sanjay Dutta (29), S/o- Subhash Ch.
