With due honour I Sri Ganesh Saha s/o Sri Nikhil Saha resident of Chaltatala ward No. 04 , P.O. & P.S. & District-Kokrajhar, Assam do hereby lodge this complaint to the effect that myself and my elder brother Sri Bapan Saha are the owner and possessor of land measuring about 2 ½ Kathas appertaining to R.S. Khatian No. 255/41, R.S. Plot No. 49, Sheet No. 20 Mouza-Dabgram, Pargana-Baikunthapur, Police-Station-New Jalpaiguri (earlier- Bhaktinagar), District-Jalpaiguri . That myself and my elder brother named above jointly purchased the said land of 2 ½ Kathas from its the then owner Sri Babun Dutta son of late Subal Dutta of Arbinda Pally near Samar Biri Factory Siliguri , P.S. Siliguri , District-Darjeeling through Registered Sale deed being No. 3942 dated 5.11.2012

It is pertinent to mention that after purchasing the said land we took possession of the said land and constructed pucca boundary over of the said land by concrete up to 03 feet in all the four sides and brick wall above the concrete dhalai in all the three sides and we installed an iron gate under lock and key into the said boundary . That since purchase we enjoying the said land without obstruction from any corner. That we are paying the Khajna in respect of the said land to the Government of West Bengal up to date. That obtained Holding No. being No. 1960 in respect of our house situated on the suit land , from the Fulbari I Gram Panchayat and paying holding tax regularly. That we also paying the land revenue regularly to the Government of West Bengal.

That after obtaining and taking possession of the above mentioned land we applied for mutation and after proper verification and measurement the BL & LRO Rajganj mutated our name in respect of the suit land mentioned in Schedule below and separate L.R. Khatian was opened in our name. That the L.R. Khatian No. 419 comprising L.R. Plot No. 298 , J.L.No. 02, L.R. Sheet No. 204, land measuring 01 Kathas 04 (Four) Chhataks (0.0207) acre , under Mouza-Dabgram , P.O. Sahudangi Hat, P.S. New Jalpaiguri, District-Jalpaiguri, is opened in the name of mine and similarly the L.R. Khatian No. 423 comprising L.R. Plot No. 298 , J.L. No. 2, L.R. Sheet No. 204, Land measuring 01 Katha 04 Chhataks (0.0206 acres) is opened in the name of my brother Bapan Saha .
