I Sneha Paul nee Das, Wife of Sri Pritam Das, resident of Sarat Chandra Sarani, Hiran Apartment, near Suryanagar Math, Dabgram, Ward No.23 of S.M.C, P.O-Rabindra Sarani & P.S-Siliguri, District-Darjeeling, Pin-734006 do hereby inform you that yesterday night at about 10:45 P.M when my husband Sri Pritam Das went to bring food from the delivery boy, **1) Sri Prasad Majumder @ Laltu, Son of Late Pachu Majumder, 2) Sri Animesh Guha @ Samu, Son of Late Pijush Kanti Guha, 3) Sri Mintu Raha Roy, Son of Late Kirti Narayan Raha Roy 4) Sri Nobin Roy, Son of Late Naresh Chandra Raha Roy 5) Sri Malay Raha Roy, Son of Late Kirti Naraayan Raha Roy 6) Sri Rajataditya, Son of not known, all resident of Dabgram** started using abusive languages towards my husband in front of the delivery boy and when my husband revolted to this incident, all the above named

miscreants started beating my husband with fists and blows and thereafter my husband called me and my cousin brother to rescue him from them. Thereafter we ran to the spot i.e. near Suryanagar Math to rescue my husband we saw that my husband was being brutally assaulted by the miscreants, I requested the miscreants to stop beating my husband the accused No.1 started molesting me by pulling my nighty and used slang languages towards me.

The miscreants snatched my gold chain weighting about 22 gm from my neck. Even after then I, my husband and my cousin brother Sri Ryan Paul, Son of Late Krishna Chandra Paul was beaten by the miscreants and was subsequently treated at Siliguri District Hospital.

I therefore request your good office to look into the matter and take necessary action against the miscreants as per law of the lands.
