I, SHYAMAL NASKAR, son of Late Gopal Naskar, resident of Surya Sen Colony, C-Block, ward No. 34 under S.M.C., P.O. & P.S. Bhaktinagar, Dist. Darjeeling, would like to inform you that as follows:-

1. That I am an Owner cum driver of one CITY CAB bearing Registration No. WB 73F-8811. Since three years I have been running my aforesaid city cab over NJP to Phansidewa, Gwaltuli Via Gate Bazar, H.C. Road, Matigara, Medical college under Government permit vide No. 5404/2004 peacefully and lawfully.
2. That on 02.12.2023 at about 7 P.M. as usual when I parked my city cab and was waiting for picking passengers of NJP station at Anchal medical more, Vill. Kawakhari, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling than one person namely SUKUMAR SINGHA, son of Ajak Singha, resident of Dangapara, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, who was already present at spot along with his TOTO came towards me and without saying anything started to assault me with fists, kicks and blows on my persons. I was astounded and when I asked him about his treatment he threatened by saying "Don't dare to pick passengers from here again otherwise I will bury you alive. Go away". When I informed him that I shall lodge a complain against you and was leaving from the spot and was going towards my city cab than suddenly said SUKUMAR SINGHA struck me with a bamboo on my head from back and continued to struck me on my head by saying that I will kill you today. As a result I fell on the road and started to bleed. Few people around helped me to board on my city cab and then I went to NBMC hospital. At present I am under treatment.
