Sub - Dowry Harassment and attempt to murder

Respected Sir,

I am writing this letter to inform you, that, I, Mrs. Sita Devi, wife of Bishal Prasad, resident of Siliguri, Bartala, Naya Bazaar, Near Jingle Bell School, I am in great trouble. My-in-laws beat me a lot and demand dowry. My marriage took place on 9th March, 2023. Just after 2 days my-in-laws started harassing me, earlier they used to just taunt me, but I did not say anything because my parents are very poor. After 1 month of marriage, my mother-in-law started beating me. She kept looking for any excuse to beat me and said that she wanted Rs. 5 lakh from my parents. I was beaten so much by my-in-laws that I was admitted to the hospital for 6 days.

21/12/23

I had an operation on my stomach. I was admitted in Siliguri District Hospital on 3rd June, 2023. At that time, I was complaining to the police station, but all the family members asked me for forgiveness and said that they will not do such things with me. My mother-in-law is so clever that she immediately threw away all the hospital documents so that no evidence remained. My parents did not let me go to my-in-law's house after the operation because my condition was very bad. But after a few days my mother-in-law herself came to call me in a very polite and lovely way, but after 2 to 3 days she started harassing me mentally. My mother-in-laws says that if I don't ask for money from my parents, she will kill me. She even tried to kill me several times. Once she forcibly tied a rope around my neck, and I was crying a lot and trying to escape from her, luckily I survived. But she still did not stop, one day she threw kerosene oil on my body and was trying to set me on fire.

I ran away from her house and came my parent's home. Not only my mother-in-law, my husband, brother-in-law, father-in-law but also my mother's-in-law's sister's family torture me. My husband and brother-in-law beat me a lot after drinking alcohol and tell me to bring money from my father's house. Recently I have been living with my parents for more than 2 months, I have not visited my-in-laws but daily my-in-laws call me that I should come home after getting some money. On 2nd December, 2023 they again called me for the same thing, that, I should ask money from my parents, I told them, neither I will ask money, nor I will come to your house, there is some clothes of mine, which is in your house, I will come with my uncle and parents just give me my clothes, and they said "OK". Next day that means yesterday I went with my parents and 2 uncles (mama, mawa) in their house. When I went inside, my mother-in-law caught hold of me and asked me, whether I came with Rs. 5 lakh or not.

21/12/23

I said "NO", then she started beating me, my mother, and father both. My mother-in-law threw kerosene oil on me and said that she will kill me. Anyhow my uncle saved us and brought us home. This incident took place in my-in-laws house at afternoon on 3rd December, 2023. After that, I was with my patients in my patient's house, and my uncle told me, that, I have to case a file against them. At evening, nearly 7 pm, my-in-laws came with almost 15 goons and they all started demolishing my house, and my mother-in-law, brother-in-law, mother-in-law's sister, her husband and her son started beating us badly. They beat me and my parents very badly and those people were finding my uncle (mama) to kill him, because earlier he rescued us. They took uncle's number from my phone and called him, asking him to meet them alone, and threatening to kill him.

Now, both me and mother have been admitted to the hospital. They have beaten me to such an extent that my condition is very bad and my mother has also been beaten in a very bad way.

Right now, they all ~~are~~ are looking for me, my parents and my uncle to kill us.

So, I, kindly request you, please give us a police protection or protect us, and I am mentioning below the names of my-in-laws who are torturing me, and also mentioning the names of my family members so that you can protect them. I don't know my mother-in-law's sister name, but please find her, she is the most dangerous person. Everyone says her

'Lal Jaijee Wali'.
