Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Prem Kumar Prasad, S/o Lt. Shew Nath Prasad, Rishi Arabinda Road, Hakim Para, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 04.12.2023 at about 03.15 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential building of Prem Kumar Prasad and inspected service installation, metering installation of Consumer ID 412023135 in the name of Lt. Shew Nath Prasad. During inspection it was found that user Prem Kumar Prasad supplying electricity from the energy meter of Consumer ID 412023135 unauthorized and illegally to the disconnected & defaulted premises of Consumer ID 412057359 in the name of Lt. Dharna Prasad that was disconnected previously on 07.11.2023, due to non-payment of outstanding energy bill.

As unauthorised supply of electricity to the disconnected & defaulted premises was detected through the energy meter make Bentec Electricals & Elec Ltd, serial no.- B2108609 installed against Con Id. 412023135 seized by preparing a formal seizure list duly signed by Prem Kumar Prasad and witnesses. The copy of the seizure list handed over to Prem Kumar Prasad and his signature obtained as token of receipt.

As Prem Kumar Prasad, S/o Lt. Shew Nath Prasad have committed offence u/s 135(1)(e) of Electricity Act 2003 by supplying electricity illegally & unauthorisedly to the disconnected & defaulted premises, you are requested to take cognizance of the same by treating this complaint as FIR.
