In producing herewith one arrested accused person namely Kala Barman (40yrs) S/o. Lalit Barman of Kamatpara, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12(Twelve) sealed Bottles of Himalayan Gold 60 UP Country Sprit containing 600 ML each.


I, ASI. Mantu Barman of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 04.12.2023 at 13:50hrs. vide Ambari Falakata GDE No-112 dt- 04.12.2023 I was performing mobile van duty at Ambari Falakata OP area. At 17:45 hrs during my mobile van duty I received a source information from Kamatpara, under Ambari Falakata OP that the above noted person has gathered huge amount of liquor illegally at his house for selling the same in the customer for his wrongful gain. I informed to O/C Ambari Falakata OutPost about the information. As per his kind instruction I along with, (1) C/824 Satyaban Das and (2) NVF 056 Anupam Barman all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Kamatpara under Ambari-Falakata OP to work out the information. At 18:45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of the above noted person, situated at Kamatpara and recovered the above noted articles from the possession of accused person namely Kala Barman (40yrs) S/o. Lalit Barman of Kamatpara, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. Accordingly I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person in presence of witnesses namely (1) Abhijit Majumder S/o. Lt. Ashim Majumder of Mahamaya Colony, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri and (2) Const. 824 Satyaban Das of Ambari-Falakata OP, under NJP PS,SPC. The seizure was made in between 19:05 hrs to 19:35 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Kala Barman (40yrs) S/o. Lalit Barman of Kamatpara, PO-Sahudangi Hat, PS-NJP, Dist- Jalpaiguri under proper section of law.
