Sir,
I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Debadrita Dutta Joardar (Ghosh), Risi Arobinda Road, C/O- North Bengal Decoretor, Hakimpara, Siliguri, Dist- Darjeeling for having committed offence as stated here under.

On 05.12.2023 at about 04.05 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the commercial building of Debadrita Dutta Joardar (Ghosh) and inspected service installation, metering installation of Consumer ID 412053941 in the name of Lt. Anjali Dutta Joardar. During inspection it was found that electricity was being used unauthorisedly & illegally by Debadrita Dutta Joardar (Ghosh) by reconnecting the disconnected service line of the metering installation that was disconnected previously on 11.02.2021 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Landies & Gyer Ltd, serial no.- L0900847 installed against Con Id. 412053941 seized by preparing a formal seizure list duly signed by Debadrita Dutta Joardar (Ghosh) and witnesses. The copy of the seizure list handed over to Debadrita Dutta Joardar (Ghosh) and her signature obtained as token of receipt.

As Debadrita Dutta Joardar (Ghosh) have committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
