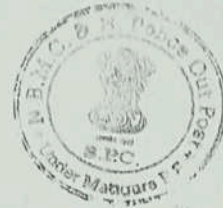

Subject: FIR

Sir,

In producing herewith one arrested accused person named Moneswar Roy (32) S/O Late Nilkanta Roy of Patiramjote, PS Matigara, Darjeeling along with seized vehicle bearing Registration No WB/73D-2484 (Tata Dampar) loaded with sand along with original seizure list and do hereby lodged this complaint against the driver of above noted seized vehicle.

I SI Ganesh Ray of NBMC Police Out Post under Matigara PS, SPC do hereby lodge this written complaint against the above named driver of vehicle having Registration No WB/73D-2484 (Tata Dampar) loaded with sand to the effect that, today on 05/12/23 morning at 08:55 hrs I received secret source information that one truck loaded with sand (which was loaded illegally from Sudhirghat of the Balason River) is coming from Sudhirghat side under NBMC OP area and proceeded towards Desun Hospital side, Asian Highway-II without any Royalty/valid documents. Accordingly I informed the matter to O/C NBMC OP under Matigara PS and diarised the information in General Diary. This refers NBMC OP GDE No-853 dated 05/12/2023. Then as per his kind direction I along with ASI Nayan Kr Das, ASI Krishnendu Roy, CV-638 Partha Biswas left for Sudhirghat side to verify the veracity of information. Then at 09:15 hrs we reached at Sudhirghat side and found that one track having Registration No WB/73D-2484 (Tata Dampar) loaded with sand is coming from Sudhirghat side of the Balason River. Accordingly we detained the above noted vehicle having Registration No WB/73D-2484 (Tata Dampar) loaded with sand and demanded the valid documents of said sand. But the driver of above noted vehicle failed to produce any documents like Royalty and others and confessed that he carrying this sand illegally for his gain. Under the above circumstances there is sufficient reason to believe that, the driver of above noted vehicle stolen this loaded sand from Sudhirghat of the Balason River without any legal royalty/papers for selling it's clandestinely. Accordingly, I seized the said vehicle having Registration WB/73D-2484 (Tata Dampar) loaded with sand under proper seizure list duly signed by witnesses and arrested the above noted driver named Moneswar Roy (32) S/O Late Nilkanta Roy of Patiramjote, PS Matigara, Darjeeling. The search and seizure were made in between 09:25 hrs to 09:50 hrs today on 05/12/23.

Under the above circumstance I pray before you that a specific case may kindly be started against the driver of vehicle Registration No WB/73D-2484 (Tata Dampar) named Moneswar Roy (32) S/O Late Nilkanta Roy of Patiramjote, PS Matigara, Darjeeling and arrange for its investigation.
