


A detailed enquiry was conducted, revealing that the incident occurred within the jurisdiction of Matigara Police Station.

Subject: Application to file FIR for harassment, blackmailing, and defamation.

Respected Sir,

I beg to state that I, Lakhimi Jogendranath Chutia, D/o. Jogendra Nath Chutia, W/o. Nirupam Paul, resident of 4.I.E Srishti Residency, Jaiukbari-14 has been facing harassment at the hands of Mr. Nirupam Paul, resident of Siliguri, West Bengal. The named person is my husband, and he has been sending messages to my sisters Miss Runum Chutia, Miss Manju Chutia, Miss Ranju Chutia and my brother Mr. Roshan Kumar Chutia, my relatives including brother-in-law and within my professional friend circle and my University Professor stating that I tried to honeytrap him into marriage. He has also been defaming me by questioning the legitimacy of my child. He has been passing all derogatory comments and messages through WatsApp, Facebook, and email to everyone questioning my character. By doing this, he has been trying to defame and malign my name and my family's name in public.

Some of the screenshots of the messages sent on Facebook and Watsapp are attached with this intimation letter for your necessary action. It is also to inform you that one Domestic Violence case bearing Case no. 171m/2022 is running on him at the Court of Judicial Magistrate First Class Kamrup (M) at Guwahati. Another cases, 1) F.C. (Civil) 1056/2022 and 2) Misc. (i) case no. 164/2022 is pending in the Court of the Principal Judge, Family Court, Kamrup (M); at Guwahati. The said DV case had been filed against him by me due to the emotional, psychological, physical and sexual harassment I had received at the hands of my husband Mr. Nirupam Paul, and his mother Khela Paul. I was beaten and harassed by him and his mother during my pregnancy and immediately after the delivery of the child. Due to this, my family members had to visit his house and bring me and my 18 days old baby from my matrimonial home in Siliguri, West Bengal.

Kindly take immediate necessary action as Mr. Nirupam Paul has been trying to tarnish my reputation in my family and my society.
