Firoz Ali, s/o - Md. Jamshed Ali, residence of Bhejiapuri lower Bagdogra, came in front of me and he started to pick a passenger in sharing but sharing of passenger is not allowed in our airport. He was drunk on that time. I told him to not to do this but he started using stangs. I oppose him and tried a lot to make him understand but he was not listening the single word and he started abusing me and giving threaten to me. on that I went to start my vehicle he suddenly came and started hitting me from my back. I tried to escape and some of our drivers also helped me on that time when everyone hold him then he tried to snatch my gold chain from my neck. The gold chain was broken and it was in pieces. He took one piece of the chain with him. He also threatening me again and again that if I came to Airport then he will see me and anything can happen. He again came to me and started pushing me on that time I have Rs. 4200/- in my pocket which is missing. Then the people took him away and I came to Bihar more.

So, I request you to take necessary action regarding the issue that I can go to airport without any fear.
