Sir,

In producing herewith 01 (one) arrested accused person named Bittu Kumar Singh (20 yrs) S/O Naresh Singh of Vill- Juran Chhapra, PO-Kisunpur, PS- Jalalpur, Dist.- Chhapra, Bihar under arrest along with following articles under proper seizure. The ground of arrest duly been communicated with him.

- (i) One black colour bag styled as "SPRIT" containing 12 bottles of "ROYAL CASTLE" BLUE PREMIUM WHISKY, Blended bottled by Mount Distilleries Ltd, Mazitar, Rangpo, Sikkim each bottle containing 375 ml (Total 375 ml x 12 = 4.5 ltrs) and marked as Exhibit "A" out of which 01 bottles taken as sample for examination and marked as Exhibit "A1".

I, SI Biplab Kr Das S/O Nikhil Das of Pradhan Nagar PS, SPC would like to lodge this written complaint against the above noted arrested accused person named Bittu Kumar Singh (20 yrs) S/O Naresh Singh of Vill- Juran Chhapra, PO-Kisunpur, PS- Jalalpur, Dist.- Chhapra, Bihar to the effect that today on 08.12.23 at 20.05 hrs I received a specific source information that one person with a black colour bag in his hand containing illegal liquor is waiting at Siliguri Junction near Delhi hotel for a Bihar bound bus. Accordingly, the matter was diarized in General Diary vide Pradhan Nagar PS- GDE No 391 dated 08.12.23 and informed the fact to the I/C, Pradhan Nagar PS and as per his kind order and direction myself along with SI Youel Lepcha, ASI Monoj Kr Roy C/473 Amrita Sarkar all of Pradhan Nagar PS left for Siliguri Junction near Delhi hotel to verify the veracity of the information in hand. After arrival at Siliguri Junction, and as identified by the source we managed to apprehended one person with a black colour bag in his possession. On being asked he disclosed his identity as noted above and also disclosed that he collect illegal liquor from one of his supplier with a view to sale the same in Bihar for his wrongful gain. On search the bag found in his possession the above noted illicit liquor recovered from his possession. On demand he failed to produce any valid license/papers in respect of the above noted illicit liquor recovered from his possession. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license since long for his illegal gain. Accordingly, I seized and labelled the above mentioned illegal illicit liquor under proper seizure list in presence of witnesses and subsequently, arrested the above mentioned detain person named Bittu Kumar Singh (20 yrs) S/O Naresh Singh of Vill- Juran Chhapra, PO-Kisunpur, PS- Jalalpur, Dist.- Chhapra, Bihar after observing all sorts of formalities at the spot. The whole process of search, seizure and label has been made in between 20.35 to 21.10 hrs.

Under the above noted fact and circumstances I, pray before your good self that specific case may kindly be initiated against the accused person namely Bittu Kumar Singh (20 yrs) S/O Naresh Singh of Vill- Juran Chhapra, PO-Kisunpur, PS- Jalalpur, Dist.- Chhapra, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
