## INSPECTOR IN-CHARGE BHAKTINAGAR POLICE STATION, SILIGURI POLICE COMMISSIONERATE

Sir,

In producing herewith two arrested accused persons namely (1) Md. Jahangir-33yrs s/o Md. Jafir of Jhankar More, Koila Dipo near Madrasa, W/No- 07, PS- Siliguri, Dist. Darjeeling (not verified) and (2) Rubel Mia-28yrs s/o Kaiful Seikh of Duisatabighi, PS- Kaliachak Dist-Malda (not verified) along with the following seized articles under seizure as per seizure list:

[i] One (01) transparent zipper plastic containing 284 grams (two hundred and eighty four) said to be Brown Sugar found in right pants pocket of accused Md. Jahangir.

[ii] One (01) transparent zipper plastic containing 287 grams (two hundred and eighty seven) said to be Brown Sugar found in left pants pocket of accused Rubel Mia.

[iii] One VIVO mobile having IMEI No- (I) 866807064400295 & IMEI (II) 866807064400287

[iv] One NOKIA key pad mobile having serial no 357749100234955

I, PSI Koushik Raha s/o Jitendra Raha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 08.12.23 at about 15.05 hrs, I received a reliable source input that two male persons were coming at P.C. Mittal Bus Stand with huge quantity of brown Sugar for delivering the same to their designed customers at Siliguri area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No.365 dated 08.12.23 and subsequently, I informed the matter to the I/C Bhaktinagar PS,SPC in writing and being directed by him, myself along with SI Srimanta Chatterjee, SI Mrinal Basunia, SI Rantu Haldar, SI Binod Jha, ASI Chandra Prakash Adhikary, Const/912 Nakul Chandra Singhawith investigation kit (envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. left for P.C.Mittal Bus Stand under Bhaktinagar PS by govt. vehicle to verify the veracity of the information vide Bhaktinagar PS GDE no. 366 dated 08.12.23 and M.C.C No- 1812 Dated 08.12.23.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at 15.25 hrs we reached at P.C.Mittal Bus Stand and I informed to PSI Dipankar Roy (K-38 II) van officer to remain present there and meanwhile called two independent witnesses namely; (1) Ujjwal Ghosh-40yrs S/O-Sanatan Ghosh of Erera, PO-Shimulia, PS- Salar, Dist.Murshidabad A/P C/O- Dipesh Kar of 45/4 Baghajatin Colony, PS-Pradhan Nagar, Dist. Darjeeling (9732760261) (staff of Bijay F.L.ON Shop at P.C Mittal bus stand) and (2) Jiban Roy-48yrs s/o Birendra Nath Roy of Beltora, PS-Kumarganj, Dist. Dakshin Dinajpur A/P staff of P.B. Bar & restaurant at P.C. Mittal Bus Stand, PS- Bhaktinagar, Dist. Jalpaiguri (9083729390) and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being identified by source and with the help of SOG team SPC we detained two persons and disclosed our identity and the information in hand and stated them that they will be searched for the purpose. At this, they disclosing their name and address as noted above and admitted that they have illegally possessed brown sugar in their possession for selling the same to their designed customers as per requirement for their wrongful gain.

PSI Koushix Raha Blox Hnogan Ps. SPC. Then he agreed to be searched in presence of Spl Executive Magistrate. Then he agreed to be searched in presence of Spl Executive magistrate. Accordingly, I informed the matter to Shri Gyalsen Lepcha, Assistant Commissioner of Police (East-II), SPC, as a Spl Executive Magistrate, regarding the interception of the accused persons suspected to be possessed Brown Sugar and requested him to come at P.C.Mittal Bus Stand In front of Bijay F. L. ON Shop to remain present and to supervise the search and seizure.

Accordingly at 18.25 hrs Shri Gyalsen Lepcha, Assistant Commissioner of Police(East-II), SPC, arrived at P.C.Mittal Bus Stand In front of Bijay F. L. ON Shop as a Spl. Executive Magistrate and subsequently, under his supervision in presence of witnesses the process of search of the detained persons for conducted following all formalities keeping his decency and recovered the above noted articles from the Joint possession of above noted accused persons. Subsequently, being demanded in presence of Shri Gyalsen Lepcha, Assistant Commissioner of Police (East-II), SPC as a Spl Executive Magistrate the detained persons failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packets with the weighing instrument and found total (i)284 grams & (ii) 287 grams = (Total 571 grams) Said to be Brown Sugar which was kept inside two zipper plastic of above noted accused persons. Then, I seized the above noted articles at P.C.Mittal Bus Stand In front of Bijay F. L. ON Shop under proper seizure list duly signed by the independent witnesses. I also labeled and sealed all the articles under the supervision of Shri Gyalsen Lepcha, Assistant Commissioner of Police (East-II), SPC as a Spl Executive Magistrate and witnesses and accused persons. The whole process of seizure was made in between 18.35 hrs

to 19.10hrs.

Then, I arrested the above noted accused persons (1) Md. Jahangir-33yrs s/o Md. Jafir of Jhankar More, Koila Dipo near Madrasa, W/No-07, PS-Siliguri, Dist. Darjeeling (not verified) and (2) Rubel Mia-28yrs s/o Kaiful Seikh of Duisatabighi, PS-Kaliachak Dist-Malda(not verified) after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused (1) Md. Jahangir-33yrs s/o Md. Jafir of Jhankar More, Koila Dipo near Madrasa, W/No-07, PS- Siliguri, Dist. Darjeeling (not verified) and (2) Rubel Mia-28yrs s/o Kaiful Seikh of Duisatabighi, PS- Kaliachak Dist-Malda(not verified) are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Nitai Chowdhury (M/60 yrs) S/O- Lt. Samapada Chowdhury of Shivarampally, Haiderpara, W/no- 37, PS Bhaktinagar Dist Jalpaiguri (ph no-6297630983).

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Md. Jahangir-33yrs s/o Md. Jafir of Jhankar More, Koila Dipo near Madrasa, W/No- 07, PS- Siliguri, Dist. Darjeeling (not verified) and (2) Rubel Mia-28yrs s/o Kaiful Seikh of Duisatabighi, PS- Kaliachak Dist-Malda(not verified) also arrange for its investigation.
