
Sir,

In producing herewith one seized vehicles bearing registration no WB 76/2170 (Damper) loaded with sand. I ASI Prem Bhakta of NBMC OP Under Matigara PS lodged a written complaint against the driver & owner of the above mentioned vehicle, to the effect that today on 06/12/2023 in course of morning mobile van duty vide NBMC OP GDE No-127 dated 06.12.2023 and MCC No-1360/23 dated 06.12.2023 I along with C/794 Saharukh Hussain and CV/638 Partha Biswas reached at Sudhir Ghat of the Balason River under Matigara PS and found that some persons were loading river bed materials (Sand) in a Truck (Damper) and the Truck have in the middle of the river. Seeing the Police van the driver of the above noted vehicle and others were fled away from the spot. Under the above circumstances there is sufficient reason to believe that the above noted vehicle's driver & owner have stolen river bed materials from the river of Balason at Sudhir Ghat for selling clandestinely. Accordingly, I seized above noted vehicle having Reg No- WB 76/2170 (Damper) loaded with river bed materials (sand) under proper seizure list. The search, seizure was made in between 13:15 hrs to 13:35 hrs on 06.12.2023.

Under the fact and circumstances I pray before you a specific case against the driver & owner of above noted vehicle may kindly be started and arrange for its investigation.


