Sir,

In producing herewith one seized vehicles (Tractor along with trolley) bearing registration no WB 73/TC -164 loaded with sand. I ASI Bijay Khaskel of NBMC OP Under Matigara PS lodged a written complaint against the driver & owner of the above mentioned vehicle, to the effect that today on 06/12/2023 in course of evening mobile van duty vide NBMC OP GDE No-136 dated 06.12.2023 and MCC No-1365/23 dated 06.12.2023 I along with C/131 Kanu Ram Sarkar and C/989 Subhadeep Roy reached at Neemtola Ghat of the Balason River under Matigara PS and found that some persons were loading river bed materials (Sand) in a trolley of a tractor and the tractor have in the middle of the river. Seeing the Police van the driver of the tractor and others were fled away from the spot. Under the above circumstances there is sufficient reason to believe that the above noted tractor driver & owner have stolen river bed materials from the river of Balason at Neemtola Ghat for selling clandestinely. Accordingly, I seized above noted tractor along with trolley bearing registration no WB 73/TC -164 loaded with river bed materials (sand) under proper seizure list. The search, seizure was made in between 14:15 hrs to 14:35 hrs on 06.12.2023.

Under the fact and circumstances I pray before you a specific case against the driver & owner of above noted vehicle may kindly be started and arrange for its investigation.
