flat-10. Went to North Bengal Medical College  
main gate at about 12.15 am <sup>on 7.12.2023</sup> to collect some  
emergency medicine. Incidentally we were attacked  
by some unknown persons with bamboo piece  
and lathie. They were almost 10 people in  
number. They were seated in front of a tea-  
stall beside Indian Overseas Bank Karakthari  
Branch.
