Sir,

I ASI Dhirendranath Mandal of Matigara Police Station do hereby lodge this written complaint to the effect that on 07/12/2023 at 20:10 hrs onwards, I received reliable source information that one vehicle bearing Reg No. WB-73-F-8100 loaded with stolen river bed material is coming out from Basbari Ghat. Accordingly informing the matter to OC PS I along with my force had been to Basbari Ghat under Matigara PS and found one vehicle bearing Reg. No. WB-73-F-8100 loaded with riverbed materials coming from the said Ghat. But on seeing the Police party approaching towards them the driver along with his accompanys fled away from the spot abandoning the vehicle. We chased them but due to odd hours of night we could not apprehend them. Subsequently we searched the vehicle for documents but could not found any and from that it could be learnt that the said driver was engaged in mining and transporting of river bed materials from Basbari Ghat under PS Matigara illegally for their wrongful gain. Accordingly, I seized the above noted vehicle bearing No. WB-73-F-8100 under proper seizure list u/s 102 Cr.PC in presence of available witnesses as stolen recover property loaded river bed materials and brought the above noted vehicle at PS.

Under the above circumstances, I pray before you that a specific case may kindly be started against the driver and the owner of the vehicle bearing No. WB-73-F-8100 under proper section of law and arrange for its investigation.
