Sir,

In producing herewith One arrested accused person named Binod Mahato (39) s/o Late Bindeswari Mahato of Himul, Bhangapol, PO+ PS- Matigara, Dist.-Darjeeling along with following articles under proper seizure list.

1. Ten (10) Bottles of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" each Bottle containing 650 ml. [Total 6.5 Ltrs] and marked as "Exhibit -A" out of which One (01) Bottle of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" containing 650 ml. taken as sample for examination and marked as "Exhibit A-1".
2. Ten (10) Bottles of "Mc Dowell's No. 21 Superior Whicky" each Bottle containing 180 ml. [Total 1.8 Ltrs] and marked as "Exhibit -B" out of which One (01) Bottle of "HIMALAYAN GOLD 60 UP COUNTRY SPIRIT" containing 180 ml taken as sample for examination and marked as "Exhibit B-1".

I, SI Sailesh Subba of Matigara P.S, SPC would like to lodge this written complaint against the above noted accused person to the effect that today on 08.12.2023 at about 19.05 Hrs. I, received a specific source information that the above noted accused person is selling illicit liquor at his house. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 439, Dated 08.12.23 and informed the fact to the officer-In-Charge, Matigara PS and as per his kind order and direction myself along with ASI Pem Dorjee Sherpa C/523 Sanjit Kundu and CVF/977 Ganesh Paswan all of Matigara PS left for Himul under PS- Matigara to work out the information in hand. After arrival at Himul ,being identified by the source we held raid at the house of said Binod Mahato and managed to apprehend said person. On being asked he disclosed his identity as noted above. Further in presence of witnesses and in presence of the apprehended person I, along with my accompanied team searched his house and recovered above noted huge amount of illicit liquor from his house. On demand he failed to produce any valid license/papers for selling and storing illicit liquor. On further interrogation he stated that he has been involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under proper seizure list and arrested the above noted accused person named Binod Mahato (39) s/o Late Bindeswari Mahato of Himul, Bhangapol, PO+ PS- Matigara, Dist.-Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 24.03.23 in between 19.35 Hrs to 20.05Hrs.

Under the above noted fact and circumstances, I, therefore, pray before you that a specific case under proper section of law may kindly be initiated against the arrested accused namely Binod Mahato (39) s/o Late Bindeswari Mahato of Himul, Bhangapol, PO+ PS- Matigara, Dist.-Darjeeling and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
