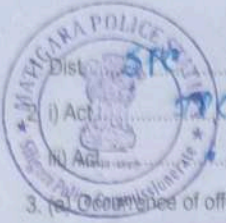

They also broke my house by using sharp cut weapon. They also threatened that they will burn us with our children by lock the house from outside if we will not leave our residential house.

Sir, the aforesaid persons are very notorious and we are very much afraid because they can do anything against us and I therefore request you to kindly take appropriate legal action against the aforesaid accused persons and help me to protect my life & property.
