**Sub: Written Complaint.**

Madam,

With due respect I, Smt. Hema Upadhaya, Daughter of late Prasad Upadhaya, resident of Rangia, Backside of Paper Mill, P.O. New Rangia, P.S. Matigara, Dist. Darjeeling, presently residing at Near Mahishmari School, Milan More, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, would like to intimate you that a marriage was solemnized in between me and one Chandra Ranjan, Son of Sri Ganesh Prasad Raman, resident of Kendriya Vidyalaya Campus, Teacher Colony, Langra Bagan, P.O. & P.S. Katihar, Dist. Katihar, Bihar on 13.12.2021 and this marriage was the result of loving relation in between me and said Chandra Ranjan and before marriage said Chandra Ranjan portrayed himself as a gentleman having love and care for me, but after a week of aforesaid marriage I surprisingly found that he is a violent character person and without any rhyme and reason he used to molest me and also assault me both physically and mentally.

That at the time of marriage my widow mother as per the demand of said Chandra Ranjan and his family members managed to give Rs.3,50,000/- in his Bank Account, valuable gold ornaments and several valuable gifts and utensils but inspite of getting such dowry from my widow mother's hard earned life savings said Chandra Ranjan used to demand more dowry from me and from my widow mother, but when I refused he

used to assault me very badly. Thereafter in the month of April, 2022 I am compelled to leave my matrimonial house due to immense mental and physical torture and continuous demand of dowry. Since then said Chandra Ranjan i.e. my husband often visited my widow mother's tenanted premises on several occasions in drunken condition and abused me and my widow mother and also threatened me with dire consequences.

Madam, on 10.09.2023 he took me at Bangalore with the assurance for my proper treatment, but after reaching there he forced me to go with him otherwise I have to face extreme consequences.

I somehow managed to free myself from his evil clutches and fled away to come back to my widow mother's present residence. He also hacked my whatsapp and facebook accounts with evil intention and threatened me again and again on cell phone.

Madam, finding no other alternatives but take shelter of law I am lodging this complain before you to take drastic legal action against said Chandra Ranjan and your good cooperation is very much expected in this regard.
