Respected Sir,

I want to bring to your attention that I am the recorded owner of land measuring 49 Decimal, recorded in L.R Khatian No. 2978, L.R Plot No. 261, Mouza - Sishabari, J.L. No. 41, Dist. Darjeeling, by registered Sale Deed No.-8379 & 8380 of year 2019.

On 01.12.2023 in the evening I got information that 6 - 8 persons under the leadership of Mr. Bhandu Oraon and Mr. Ashok Roy Yadav, both residents of Kolabari, near Sai Mandir, P.O - Champasari, P.S- Pradhan Nagar, Siliguri have come to my said land and planning and preparing to construct brick boundary wall inside my land on the pretext of measuring our land without any legal authorization from me or any concerned authority.

I rushed to the spot and found that 5 to 7 persons who are famous land grabbers in the locality, and now they under the leadership of Mr. Bandu Oraon and Mr. Ashok Roy Yadav are loitering inside my land premises to take forceful possession and suddenly they started abusing me in filthy and coarse language and they also said that they are influential people with high profile connection. When I started to resist these people a brawl broke out and 2 of these people hold me and Bhandu Oraon punched me in my stomach and slapped me many times. With the help of neighbours I managed to somehow get these people out of my land.

I want to mention that out of 3 to 4 persons I found three person also tried to encroach the said land before also, but failed due to strong protest from me and my well wishers. I have also lodged a written complaint on 22.04.2023 at Pradhan Nagar Police Station and on 3rd.July, 2023 at the Commissioner of Police, Siliguri over the previous incident.

Please note that Mr. Bhandu Oraon and Mr. Ashok Roy Yadav has threatened to file false criminal complaint against me and my father under Scheduled Caste and Schedule Tribe (Prevention of Atrocities) Act since both the person are from Schedule Tribe and/or caste.

These accused persons left warning that they will return again and take away my land. They have given me serious threatened that if I tried to resist them next time they will cut me in 3 (three) pieces and bury me in the said land. Further threatened me that they will drop 2 trucks of bricks in the said land and required amount of sand for creating boundary wall, and if anyone comes to disturbed then he will not be able to return to his house on his own legs. In such situation I felt scared and unsafe thereby somehow I return back from my land premises and now it is not possible for me to go again in my land premises.

Even at present there has been frequent disturbance in my peaceful possession of land and for said disturbance I couldn't construct anything on my land because they are disturbing me with his muscle power with the help of local goons. They are constantly harassing me physically and mentally for their dubious claim and I being alone without any local support surviving in a danger situation for their ill motives.

In view thereof, it is urgently required your kind interventions, make necessary inquiry, and to take appropriate and necessary action to punish them and their man and associates and urge you to take strict cognizance of the matter.
