The company Namely Microtalk Communication Pvt Ltd is engaged in the business of providing VOIP, Broadband, ILL and also giving Network service across the India. By providing quality service over the course of its existence, the business has developed a solid reputation.

I am approaching your good office with the present criminal complaint against Swapan Mondal son of Late Subal Mondal, residing at Rabindra Nagar, Rabindra Sarani (Darjeeling), west Bengal, Pin – 734 006.

That this is to draw your kind attention the said accused person namely Swapan Mondal was an employee of the Siliguri Branch. He was joined our said company namely Microtalk Communication Pvt Ltd on 1<sup>st</sup> February, 2021 as a Field Technician. But during his employment he did several illegal activities at office premises, every alternative occasion he used to visit our branch office premises in drunk, he used to create unhealthy situation, he used to disturbed our customer in daily occasion. For the above mentioned reason he has show caused many occasion by company. Ther after on dated 7<sup>th</sup> October, 2023 he was terminated by the company, he has not been comply the hand over process, still he has used the corporate SIM which has been provided by company only for the official purpose.

That today at around 4:02Pm the accused persons namely Swapan Mondal surprisingly visited at our Siliguri Branch Office with drunken condition, he destroyed all the furniture like Chair, Computer

table, he has broken One monitor. He has threatened with the filthy language upon the employee who were present on that moment, few of them heavily injured by the accused persons. Many Broadband router has been stolen by him. He was doing that illegal act unstoppable. The has threatened over phone upon the various employee of the company. The above mentioned incident has been captured by the office CCTV Camera.
