Sir,

With due respect, I Sri Harendra Singh, S/o Late Dhruv Singh, resident of Gandhi Nagar, Ward No - 43, P.O - Sevoke Road, P.S - Bhaktinagar, District - Jalpaiguri, would like to inform you that one Laxman Prasad, S/o Sri Murlidhar Prasad, resident of Nehru Road, Khalpara, P.O & P.S - Siliguri, District - Darjeeling came to my contact in the month of March 2023 and has started visiting me off and on by calling me as uncle and has started coming into close relation with me by visiting to my house after having information that I am a retired persons and has started inducing me to invest money in the choice of his company for more lucrating profits though I was egger to make fixed deposit in the nationalized bank but due to his repeated inducement and undertakings that he will assist me to invest in such a company or firm that the said company or firm will give me more and more profit and my money will be secured otherwise he will return my invested money to me.

After his repeated inducement on 14 - 7 - 2023 the said Laxman Prasad asked me to invest a sum of Rs. 50,000/- in Reel Token.com and to get my confidence he assured me that the said Reel Token will return my said money in the tune of Rs. 1,10,337 = 50 Paise after 16 month or .50 dollar per day upon 100 dollar. Upon his such inducement and believing the words and undertakings of Laxman Prasad, I have invested the sum of Rs. 50,000/- in the said Reel Token.Com through Binance App with a hope that my money is secured and I will get profit against my said investment.

But soon after my investment, the said Reel Token.Com became vanished and whenever I have informed the fact to Laxman Prasad, he started avoiding me and subsequently I started refusing to receive my telephone calls.

On enquiry I came to know from the local people even from his father that the said Laxman Prasad is a cheater one and has cheated too many persons of the locality.

Sir, the said Laxman Prasad has cheated my money amounting to Rs. 50,000/- by inducing me to invest the same in Reel Token .Com which was totally unknown to me and now he is denying to pay the money which he has undertaken to return.

So, requesting you to investigate the matter and take necessary legal actions against the above named persons for the interest of justice and for that I will highly oblige to you.
