Respected Sir,

I Ashna Sunam (Schedule Caste) Daughter of Gautam @ Goutam Sunam, Resident of Nema Jote, Matigara PIN-734010, would like to lodge a written complaint to following effects:

1. That my grandfather Late Krishna Bahadur Sunam(now deceased), my elder sister Trishna Sunam and my mother Hiradevi Sunam are the actual owner of a land measuring 1.69 Acre ----land measuring 41 Decimals recorded in Khatian no 3545(Trishna Sunam)----land measuring 1 Acre recorded in Khatian No 2664(Hiradevi Sunam)----land measuring 28 Decimals recorded in Khatian no 21( Krishna Bahadur Sunam) J.L. 59 Mouza Panchkelguri which is in our possession since the death of my grandfather.

2. That for the last one year the said Dhiraj Ghosh, Son of Late Dharendra Nath Ghosh, Resident of Gossainpur, P.O. and P.S Bagdogra, Dist. Darjeeling and his associates /goons were forcefully trying to encroach our aforesaid land but somehow we manage to protect our land from the hands of the said Dhiraj Ghosh.

3. That today around 11:51 am the said Dhiraj Ghosh sent his associates/goons namely:

- (b) **SURESH TIRKEY Resident of Paini Kumari,**
- (c) **GAGAN SAIBO Resident of Kamlabari,**
- (d) **PARVATI TIGGA Resident of Shivmandir,**
- (e) **ARUN SAIBO Resident of Sainik puri,**
- (f) **MITHU BISWAS Resident of Matigara,**
- (g) **ALOKIT @ ALOWKIT SUNAM Resident of Khaprail,**
- (h) **SAURAV @ SAURABH GHOSH Son of Dhiraj Ghosh Resident of Rupsingh Jote, Gossainpiur, Bagdogra, along with more than 300 people**



entered our said land forcefully and encroached our aforesaid land in absence of my father and brother and when I along with my mother and also with my other family members and well wishers raised protest against their illegal activity at that time they became furious and started assaulting me as well as my mother physically with kick, fist, laathi, rod on my mother's body and also threatened us with sharp weapons like daaw, khanti, khukuri for dire consequences, not even that Dhiraj Ghosh's associates/goons tore my mother's clothes challenging and outraging my mother's modesty and also used abusive and discriminatory language upon us and told my mother and me "TERA JAISA NICHA JAAT KO DOH MINUTE MEIN UTHA DUNGA" and also spat on my mother's face.

I, therefore request you to treat this written complain as F.I.R. and also take necessary actions against the said culprits and protect our land from their hands and oblige thereby.


