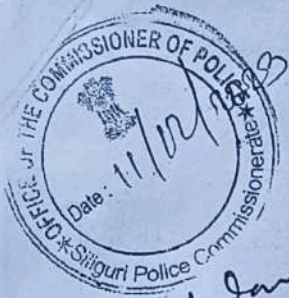

Brief of Incident:

2. On 24.10.2023 at around 12:10 am (Mid night) Mr. Sujan Das came at hub in a drunken state and started threatening the employees at hub. Mr. Surajan Das criminally intimidated Mr. Rana Chowdhury in filthy language in front of other employees and whilst doing so he assaulted him physically. That Mr. Sujan Das attached Mr. Rana Chowdhury with kicks and punches and took him out of the hub premises with holding collar and then beat him persistently. The public present there, came ahead and helped me out. Meanwhile, the security guard dialled a distress call directly at PS Matigara. The whole incident recorded in the CCTV footage.
