Sir,

I ASI Aibul Islam of Matigara P.S do hereby lodge a written complaint to the effect that on 15.12.2023 at 10:00 hrs I received information from reliable source that one vehicle Tractor fitted with Trolley bearing Reg. No. WB - 73 C 5321 being loaded with river stone coming from Jyotirmoy Colony Balason river Ghat side. On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival near Jyotirmoy Colony at Balason river Ghat side under Matigara P.S area and found one vehicle Tractor fitted with trolley bearing Reg. No. WB - 73 C 5321 loaded with river stone going towards Khaprail. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area.


As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river stone and brought at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle Tractor fitted with trolley bearing Reg. No. WB - 73 C 5321 under proper section of law and arrange for its investigation.
