Sir,

I, Smt. Parbati Tigga, Wife of Sri Manoj Tigga, resident of Bidhan Pally, Atharakhai, P.O. Kadamtala, P.S Matigara, District – Darjeeling, beg to lodge this complaint, as under:

I belong to the Schedule Tribe Community.

I have been appointed by Sri Dhiraj Ghosh, Son of Late Dharendra Nath Ghosh, resident of Gonsaipur, Post Office & Police Station – Bagdogra, District – Darjeeling as Site Manager to look after and manage the land measuring 1.00 Acre (approx) at Mouza – Panchkelguri, Khaprail Road (near Petrol Pump), Police Station – Matigara, District – Darjeeling.

I, on being appointed as aforesaid, started working as the Site Manager. On 14.12.2023 at about 01:00 p.m., when I was present at the said land, one Sri Goutam Sunam (Sinha) and his wife, Smt. Hira Sunam and one daughter, Miss Trisha Sunam, all are of Deep Nagar, Khaprail, Post Office – Nimai Jote, Police Station – Matigara, District – Darjeeling trespassed into the said land and started putting a board with their names in and over the said land.


Immediately I raised objection to the said illegal activities in and over the land and requested them to leave the spot. But all of them became furious, reacted badly and abused me stating – “Tu Shali Chota Jat ki larki, tera himmat kaise huya, hamlog jaise bara log se bat karna”. They especially Sri Goutam Sunam (Sinha) pushed me, intentionally touching my breast and thereby sexually abused me. All those incidents were happened in presence of many people.

You are, therefore, requested to enquire into the above matter and take immediate steps against said Sri Goutam Sunam (Sinha) and his wife and daughter, starting a specific case against them.
