With due regards, I, **FATEMA KHATUN**, Daughter of Late Dildar Hussain, resident of Gital Para, Iskon Road, Ashraf Nagar, Ward No.40 of S.M.C., Siliguri, P.O. Haiderpara, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint to the effect that :-

Since last year back, our mother as per the desire of my brothers have decided to sold out her aforesaid property and thereafter selling the aforesaid property our mother equally distributed the amount and property between her all sons and daughter.

That thereafter my all brother and sister including me was received the amount of Rs. 6,00,000/- (Rupees Six Lack) only each from our mother and subsequently on 02/11/2022 my two brother namely 1. Md Farid and 2. Namely Md. Idrish Hussain taken of Rs. 2,00,000/- each i.e. Rs.4,00,000/- (Rupees Four Lakh) only from me as a loan for their personal used and assured that they will returned this above amount within 2 (Two) months, but till this date they could not returned this amount to me.

That I have several time requested to my brothers for get back the above amount to me but they said that they could not returned this above amount to me because the unnecessary reason.

That Sir subsequently on 13.12.2023 when I went to my office near about 8.30 a.m. then said **Md. Idrish Hossain** and his antisocial associates attack on me near Jhankar More Fly Over and threatened me with dire consequences and abuse me with filthy and offensive languages not only that the antisocial associates of Md. Idrish Hossain has been assault or criminal force me and pulls my clothes with intent to outrage my modesty and said Md. Idrish Hossain take advantage of the situation and snatch my gold chain from my neck and when I raised objection on their said illegal acts and shouting then they fled way from the place. And they also threatened me that they will throw acid to my face and also they will ruin my life at any way at the time of leave the place.

So Sir under the above circumstances I am passing my days with great fear and anxiety.

I, therefore, request you to look after the matter and please take strong legal steps against the accused persons as early as possible as per the provision of law and obliged thereby either I will suffer irreparable loss and injury.

Your early action is highly solicited.
