I, Sri Chetan Anand S/O Sri Anand Kumar Dwivedi of Belakoba Customer Care Centre do hereby lodge a complaint being empowered by Electricity Act-2003 against Sri Dinabandhu Sarkar S/O Late Sudhiv Sarkar of VIII, Sahab Para Ambari, Jalpalguri was committed theft of Electricity under section 135(1)(a) of the electricity act 2003 at station here under.

On 12.12.2023 at about 14:10 hrs I accompanied by T.S.H, Sandip Talukdar (43 years) S/O Late Akhil Bandhu Talukdar and Raju Dutta (29 years) S/O Sri Late Sadhan Kumar Dutta attached to Belakoba C.C.C WBSedcl. and S & L.P team of Jalpalguri Regional Office (Sri Paritosh & Special Officer Sri Santa Seal) hold raid and inspection at VIII - Sahab Para, Ambari, P.S -NJP. In course of inspection we entered to the premises of Sri Dinabandhu Sarkar (39 years) S/O Late Sri Sudhiv Sarkar. He was present at the time of inspection. During inspection we noticed that Sri Dinabandhu Sarkar Consumer no-401167001, Bypass the Electric Meter no-FA491053 by tapping extra Red Collar main Service wire for theft Electricity illegally using the following items 1) One no- 2) 4 nos.- LED light, 3) One no Mixer, 4) Two nos.- Fan.

Power theft was detected, I requested local people to become witness of this fact. But nobody came forward to assist me. Finding no other alternative I seized above mentioned items, at 14:20 hrs in presence of Sandip Talukdar (43 years) S/O Late Akhil Bandhu Talukdar and Raju Dutta (29 years) S/O Sri Late Sadhan Kumar Dutta attached to Belakoba C.C.C under P.S Rajganj and duly signed by them.

Seized properties are fragile in nature, may break or destroy at the time of packing and shifting them to your Ambari Outpost (under NJP Police Station). Apprehending of the mischief I left all seized properties (1) to (4) on Zhuma to of Sri Dinabandhu Sarkar S/O Late Sri Sudhiv Sarkar, under P.S. NJP in good condition. Thereafter we left the premises.

Dinabandhu Sarkar (39 years) is an accused person who was committed theft of power of U/S 135(1)(a) Electricity Act. You are requested to take cognizance of this complaint and treat this as F.I.R.
