Subject : General diary on incident of Theft attempt - matter regarding.

Sir,

This is for your urgent information that an incident of theft attempt has taken place at the Aayakar Bhawan Building at Paribahan Nagar, Matigara during the last weekend [Between 15/12/2023 (after office hour) to the morning of 18/12/2023]. The incident was noticed by the officials/Officer when they entered the New building section (Wing-B) of the Aayakar Bhawan this morning for duty at office hour. It was found out that the 5 rooms comprising of Officers chambers & sections, ASK Centre, Almirahs, & drawers of these places were break opened, keys were misplaced and items/Files were removed and placed on the tables. Internal verification/ investigation are being made whether any confidential items or information are missing/compromised.

Prima facie, it appears a security lapse on the part of the security personnel who were on duty during the above period which needs to be investigated thoroughly.
