With due respect, I Sri. Gourab Kundu, S/o. Gopal Kundu, resident of Bidhan Pally, Bararnchan Singh Jote, P.O. Ranidanga, P.S. Matigara, Dist. Darjeeling beg to state that I am the constituted attorney of Smt. Sumi Gupta, Wife of Sri. Manoj Gupta, resident of Matigaara Bazar, P.O. & P.S. Matigara, District- Darjeeling, W.B.-734010.

That Sumi Gupta is absolute owner of a piece of land measuring about 8 decimals, recorded in R.S. Khatian No. 2/2, corresponding to L.R. Khatian No. 1713, under R.S. Plot No. 4, corresponding to L.R. Plot No. 19, situated within Mouza Thiknikata, J.L. No. 74, Pargana Patharghata, under Matigara-I Gram Panchayat, P.S. Matigara, Dist. Darjeeling having title deeds, Khatian, khazna receipts in her name in respect of said property.

That on several occasions, one Jayanta Chakraborty, S/o. Late Prafulla Chakraborty, resident of Kawakhari, Medical More, P.O. Sushrutnagar, P.S. Matigara, District Darjeeling, West Bengal-734012 along with his men and persons came to the land and threatened Sumi Gupta with dire consequences and they have forcibly tried to capture the land for their illegal gain but Sumi Gupta and her other family members raised strong protest and could restrain Jayanta Chakraborty.

Finding no other alternative, said Sumi Gupta, have filed a civil suit against above named Jayanta Chakraborty in the Court of Ld. Civil Judge Junior Division at Siliguri being Title Suit No. 297/2023 on 13.12.2023 and after hearing interim injunction petition the Ld. Court was pleased to pass an injunction order thereby directed both the parties to maintain status quo in respect of nature, character and possession of the land till 15.01.2024.

Yesterday, when I visited the land on being asked by Sumi Gupta, I found that Inspite of the aforesaid Court's Order, the above named Jayanta Chakraborty & his wife illegally trying to construct a tin shed structure in front side of the said land. Thereby they are violating the La. Civil Judge Junior Division at Siliguri Court's order by changing the nature character and possession of the said land. Being power of attorney holder of Sumi Gupta, when I resisted them from making any construction they became furious and started to assault me with sharp object and threatened me that they does not care about court's order and nobody can stop them from making such construction.

Therefore, I request you to take necessary legal action against said Jayanta Chakraborty & his wife, so that they could not violate the Court's Order.
