### Request to lodge FIR against theft of Govt Property

1. On 21 Dec 2023 at around 1130hrs, I was on patrolling duty with my staff at unit 16 FAD. At that time we notice some peoples are trying to enter my unit location. I informed to CRT and CMP control room for more staff to check that area. One ladies and ten gents staff checked that area and caught one lady and named Jareena, and one gents named Rambabu Sah with his vehical No. WB 69-8573. We caught them red handed to load Iron Ammunication Mine Pins approx Qty 574 and weight 248kgs.
2. We questioned them about items, they replied and confirmed they are stolen that items from Cantt area. On further questioning they also confirmed they have three other ladies staff with them who are runaway.
3. It is requested to mention that such theft incident had happend in the unit in last Sunday dated 17 Dec 2023. FIR of that incident has been lodged (FIR No-588/23)
