I, **Arpita Chakraborty**, D/O- Samar Chakraborty, W/O- Niru Basunia, resident of Ward No. 1, Pradhan Nagar, Panchanan Colony 2 No., Siliguri (M. Corp.), Darjeeling, Pradhan Nagar, West Bengal- 734003. Wants to draw Your attention to a matter that-

On 06-02-2022 a love marriage was solemnized between me and my husband namely Niru Basunia. From then I am residing at my husband's house with his family members. We have a child named Nirvik Basuniya aged about 10 months. From the very beginning of our marriage my husband **Niru Basunia** and his family members- **Kartik Basuniya** (Father-In-Law), **Rekha Basunia** (Mother-In-Law), **Rabindra Basunia** (Brother-In-Law) and his elder sisters namely **Mira Arya**, **Hira Baishya** & **Mampi Mohanta** used to ask money from my parental house as dowry. But I always opposed them saying that my father's financial condition is not so strong to fulfill their demands. They used to torture me mentally and threat me that they will send me back to my parental house if my parents do not fulfill their demands.

After the birth of our son their demand for dowry reached a next level. They started to torture me physically too. The family members and my husband used to lock me up in a room for a whole day whenever I told them that I want to visit my parental house. They used to separate my child from me for a whole day, when I started to cry they standing there laughing and saying that they will separate my child from me permanently. They did not used to give me proper food and used to give me foods which left after their lunch or dinner. They use

to force me to do the every work of their house like a maid. My husband never opposed his family members but supported them. I had no choice but to agree with them because I did not want to break my domestic life to end. Thus days were passing.

From some days my husband & his family members now demanding 3,00,000/- (three lakh rupees) as dowry from me & my parents and they threatened me that if within few days I do not gave them what they are demanding they will kill me and my child and my husband will remarry a new person who is financially capable to fulfil their demands and no one will ever came to know what happened to me & my child.

Now, finding no other alternatives, I came before you with a last hope that You will look into this matter and will take appropriate actions against my husband & his family members as per law. Kindly do the needful.
