In producing herewith following three accused namely i) Imran Husen @ Rahul (26yrs) S/O Lt Endad Husen of Anandamoye Colony Champasari PS Pradhan nagarDist Darjeeling, ii) Abdul Salam (23 yrs) S/O Imteyazul Haque of New Pokajote Po Champasari PS Pradhan nagarDist Darjeeling, iii) Sunny Gupta (28yrs) S/O Lt Raj Kumar Gupta of Pradhan nagar near St Thomas Schol PS Pradhan nagarDistDarjelingalong with following seized articles viz:

- 1) One improvised fire arms measuring 23 cm in length including its 13 cm barrel and 7 cm wooden butt having trigger, trigger guard, hammer, firing pin with one live ammunition recovered from the possession of Imran Husen @Rahul,
- 2) One iron made 'Knife' and one torch light recovered from the exclusive possession of accused Abdul Salam.
- 3) One iron made weapon called as 'Bhojali' recovered from the exclusive possession of accused Sunny Gupta.

I, SI Youel Lepcha of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted i) Imran husen @Rahul (26yrs) S/O Lt Endad Husen of Anandamoye Colony Champasari PS Pradhan nagarDist Darjeeling, ii) Abdul Salam (23 yrs) S/O Imteyazul Haque of New Pokajote Po Champasari PS Pradhan nagarDist Darjeeling, iii) Sunny Gupta (28yrs) S/O Lt Raj Kumar Gupta of Pradhan nagar near St Thomas Schol PS Pradhan nagarDistDarjeling and 8/9 others to the effect that today on 23/12/2023 at 00:25 hrs received a specific source information that 11/12 miscreants have assembled below Mahananda river near Parvati ghat under PS- Pradhan Nagar, Dist- Darjeeling with deadly weapons and making preparation for committing dacoity at Pradhannagar area. Accordingly, I informed the matter to the I/C, Pradhan Nagar PS and diarised the fact in General diary vide Pradhan Nagar PS GDE No 1361/23 dated 23/12/2023 and as per order I along with SI Goutam Mallik, SI sahan Ali, C/1411 Ashiok Roy, C 1169 Praasanjit Barman, C/ 473 Amrita Sarkar all of Pradhan Nagar PS, SPC, left for Parvati ghat to work out the information in hand. At about 00.45 hrs we arrived at Parvati ghat and as indicated by the source we noticed that 11/12 persons assembled at Parvati ghat and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession but 08/09 persons managed to fled away from the spot taking the advantage of darkness and open place. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally, they disclosed that they along with their associates were assembled there and making preparation for committing dacoity at Pradhan nagar area. On search the above noted weapon of offence recovered from their possession.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons i) Imran husen @ Rahul (26yrs) S/O Lt Endad Husen of Anandamoye Colony Champasari PS Pradhan nagarDist Darjeeling, ii) Abdul Salam (23 yrs) S/O Imteyazul Haque of New Pokaijote Po Champasari PS Pradhan nagarDist Darjeeling, iii) Sunny Gupta (28yrs) S/O Lt Raj Kumar Gupta of Pradhan nagar near St Thomas Schol PS Pradhan nagarDistDarjelingand others 08/09 unknown persons and arrange for its investigation.
