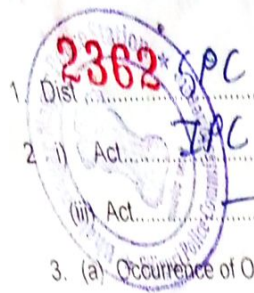

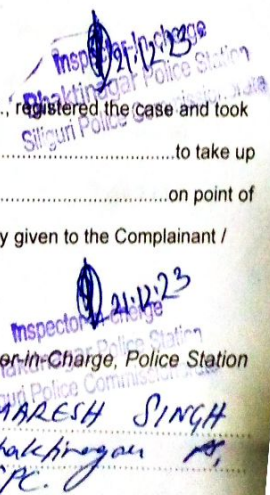

Dear Sir,

I Sri Ashok Kumar Agarwal, Son of Late Jagadish Prasad Agarwal, resident of 2nd Mile, Sevoke Road, Siliguri, Post Office- Sevoke Road, Police Station- Bhaktinagar, PIN- 734001, West Bengal would like to inform you that I am the owner in possession of a plot of land situated at Sarkarpara near Tiranga More and am constructing a residential building over my said plot of land. It is pertinent to state here that just in front of the proposed building site there is temple popularly known as 'Shiv Mandir' and there is a tree growing inside the Mandir. The branches coming out from the tree protrudes outside the Mandir and into my plot of land thereby causing significant hindrance/ blockage in the construction activities of my proposed building.

As a peaceful and law abiding citizen I accordingly informed the appropriate authorities regarding the same and accordingly sought permission to trim a portion of the branch without damaging the Mandir. I forwarded a copy of my request application to the Beat Officer, Directorate of Forests, Salugara, The Range Officer, Directorate of Forests, Salugara and to the Local Ward Councilor, Ward No.41 of the Siliguri Municipal Corporation, Siliguri. The Ward Councilor was kind enough to grant me permission to only cut branches.

Yesterday i.e. 19.12.2023 at around 02:00 p.m. as I along with my son Sri Ayush Agarwal and some labourers visited the site to trim branches of the tree at that very moment some local goons namely Kale (8670325564), Jingley (7384833282), Rikesh (9775691882) and their other unknown associates restrained my workers from carrying out their activities when I intervened Kale, Jingley, Rikesh and their other associates physically assaulted me and my son with fist and blows and abused us with filthy languages. 

state here that the aforesaid Kale, Jingley, Rikesh and other agents regularly demand money from me so that they render their cooperation in trimming the branch. In the past also there has been such kind of events and I have also reported the same to your good office on 05.04.2023 and accordingly your good office warned them from doing such activities but Kale, Jingley, Rikesh and their agents are dangerous men and enjoy political patronage and have stopped my workers from continuing construction activities and have threatened me and my son with dire consequences. Furthermore my son has sustained injury and has fractured his fingers.

I therefore request you to take note of the aforesaid fact and take necessary action against Kale, Jingley, Rikesh and other unknown agents in accordance with law and oblige.
