Sir,

I, Madhumita Roy, wife of Jagodish Burman, presently residing with my parents at house of Gayatri Devi, Kholachand Fafdi, Distt Jalpaiguri, would like to inform you that I was married to Jagodish Burman, s/o Paresch Burman, resident of, near Durga Mandir, Kholachand Fafdi, Distt. Jalpaiguri, on 9th March 2023.

That immediately after marriage and continuing ever since, my husband, both my in-laws, my sister in law and my mother in law's sister has been extremely abusive and aggressive towards me. They are physically and mentally torturing me all the time - treating me only as a bonded labour. I have been doing all the household work and taking care of the whole family to the best of my abilities and yet only get abuses and threatening all the time. They do not allow me to speak to my parents & relatives or to anyone else. They also do not allow me to step out of their house and I have to live like as if I'm a prisoner.

At the time of my marriage, my husband's family was well aware that I belong to a poor family. Even then, my parents took many loans and married me off giving all the necessary goods and furniture. However, they keep torturing me regarding this and expect me to bring more stuff and cash from my poor parents.

Since the last 4 months they are not even allowing me to go to meet my parents despite innumerable requests. And they always use filthy language against my dignity and my husband even kicked me last night on 20th Dec, 2023.

That being fed up of the inhuman treatment being meted out to me from my husband's family, I decided to leave the house very early in the morning and came to be with my mother. This I have done out of my own will after not being to tolerate anymore their constantly abusive and

aggressive behaviour and being having to stay like a prisoner.

I therefore request you to kindly take note of the above, look into the matter and do the needful.
