Sir,

I, Sri Manoj Paul, Assistant Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Manish Mandhyan, 3 Rd Floor, Charubala Abasan, Nazrul Sarani, E.V.Pally, Ward No. – 39, Siliguri, Dist - Jalpaiguri for having committed offence as stated here under.

On 21.12.2023 at about 01.55 p.m. acting on a source information I, along with 1) Sri Pranab Sikder, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Sr. T.S.H., Hakimpara CCC and other officials of WBSEDCL entered the residential premises of Manish Mandhyan and inspected service installation, metering installation of Consumer ID 401932756 in the name of Manish Mandhyan. During inspection it was found that electricity was being used unauthorisedly & illegally by Manish Mandhyan by reconnecting the disconnected service line of the metering installation that was disconnected previously on 08.03.2021 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Genus Innovation Ltd, serial no. - G01823823 installed against Con Id. 401932756 seized by preparing a formal seizure list duly signed by witnesses.

As Manish Mandhyan have committed offence u/s 135(1)(a) & 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR. The seized articles are packed and labelled by me.
