Subject: Written Complaint against Mamta Chettri, D/o Hari Prasad Chettri and her associates namely Saru.

1, Smt. Sara Das, wife of Rajen Das, presently residing at Shree Shyam Aawas, Shashtrinagar, Ward No. 41, Siliguri, P.O. Sevoke Road & P.S. Bhaktinagar, Dist. Jalpaiguri would like to lodge a written complaint against one Mamta Chetttri, D/o Hari Prasad Chettri, presently residing at Baikunthapally, Ward No. 41, P.O. Sevoke Road & P.S. Bhaktinagar, Dist. Jalpaiguri and one of her associates namely Saru, D/o not known, resident of not known, to the effect that on 18/12/2023 at around 7 A.M, the above-named persons had knocked into the main door of my home when I was all alone at my residence with my only girl child of about 2 years old and thereafter when I opened the door to which I found that the above-mentioned person who had been following me since 5-6 days had pushed me backwards to the floor and forcefully entered into my house with some ulterior motive and had started assaulting me with their fist, blows and kicks.

That it is pertinent to mention here that the above-mentioned persons had been following me and were having close eyes upon me since 5-6 days with some ulterior motive but I didn't care about the same.

That after forcefully entering upon my house these two ladies not only assaulted me with fist, blows and kicks but the lady namely Mamta Chettri had also brought a sharp knife along with her in order to fulfill her ill motive.

That the said Mamta Chettri along with her associate after forcefully entering upon my house had not only assaulted me badly with fist, blows and kicks but also caused huge damage to my several hosusehold properties i.e., T.V., Fridge, Almirah, Sofa, Tea-table, Air Conditioner, Furnitures, clothes, even groceries etc., amounting to Rs. 4,50,000/- to Rs. 5,00, 000/- (Rupees Four Lakhs Fifty Thousand - Five Lakhs only) approximately and she had also looted my cash money amounting to Rs. 37,000/- (Rupees Thirty Seven Thousand only) kept in my house, some utensils, vaccum cleaner, finger gold rings, golden chain, one Samsung Tab, one Samsung mobile phone having sim card number 93395-70637 and several other household materials from my house by placing the sharp knife upon my neck and keeping me under fear of my life with the help of the said knife which she had brought along with her.

It is also pertinent to mention here that the whole incident took place in front of my 2 years old daughter and the same has left me and my daughter under severe threat to our life and liberty as I have suffered severe injuries in several parts of my body including my private parts and I have also suffered internal injuries due to which I have been vomiting since yesterday due to the assault caused by them and thereafter one of my friend took me to Siliguri District Hospital today for my medical treatment looking after my health and physical condition.

Therefore, it is humbly requested to you to look into the instant matter at the earliest giving it the utmost priority and thereafter to take stringent action against the said above-named persons as per the relevant provisions of the law.
