Respected Sir,

I, **ABHIJIT SARKAR**, Son of Sri Amal Sarkar, resident of Hatimore, Netaji Subhash Road, P.O. + P.S.- Siliguri, District- Darjeeling, West Bengal, would like to inform you that on 19/11/2023 when I was eating food and watching world cup final match, which was going on between India vs. Australia at Cheers Bar Cum Restaurant, P.C. Mittal, Siliguri. Suddenly at about 8:30 p.m. Mohit Agarwal (Mobile- 98325-71445), Son of Late Manohar Lal Agarwal, Resident of Punjabi Para, Ward no. 13 of S.M.C., P.S.- Siliguri, District- Darjeeling, was in a badly drunken condition. Suddenly said Mohit Agarwal switched off the television and started shouting "India Hai Hai" "Mera Paisa dub gaya" "cricketer sab paisa kha liya hai" and he used several slang languages against Indian team. When I tried to switch on the television he started to abuse me and thereafter he assault me brutally by kicks and fists. Said Mohit Agarwal attacked upon me with metal object with the intention to kill me. He also snatched my purse having a sum of Rs. 5,500/- (approx) containing several documents and he also snatched gold chain, said chain was gifted by my Late Grandfather. I sustained several injuries in my body. He also threatened me with dire consequences by saying that he will murder me certainly and ensnare me in a false case by any means in order to destroy my life. Thereafter I went to Siliguri District Hospital for my treatment at about 9:10 P.M. and the Medical officer of the Siliguri District Hospital, advised for x-ray of my right hand and he told me to take rest for 7 days and suggested to take several medicines.

The entire incident has been recorded in the CCTV Camera of the Bar Cum Restaurant in between 8:30 to 8:45 P.M. and all incidents were witnessed by the *staffs and customers of the Bar Cum Restaurant*. Said Mohit Agarwal is a drug addict and He has bad reputation in the locality and several cases were pending against him. After the said incident dated 19/11/2023 I tried to settle the disputes among us but He failed to settle the disputes by taking several pleas and he started demanding a lump sum amount from me. I believed that our disputes may be settled as such did not lodge any complaint to the P.S. till now.

Therefore, I am requesting you to take appropriate legal action against the above named person as per law. For this act I shall ever remain grateful and remain obliged for the same.
