In producing herewith four (04) arrested accused persons namely (1) Md. Bappa (M/22), S/O-Md. Rafiqul of Tikiya Para, Prankrishna Colony, W/No - 28, PS. Siliguri, Dist. Darjeeling, (2) Nandu Tirkey (M/25), S/O- Sri Saharai Tirkey of Bagrakote, Chittyaranjan Colony, W/No - 20, PS. Siliguri, Dist Darjeeling (3) Raja Basfore(32yrs) S/o- Lt Dinesh Basfore of Tikiapara, Ahmedkar Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling, and (4) Sujit Lama @ Tapa (M/22), S/O- Lt. Sankar Lama of Madanibazar, Baribhasha, PS. NJP, Dist. Jalpaiguri arrested u/s- 41 Cr.P.C along with following seized articles viz:

1] One iron made Khukri measuring 18 inch (approx) including wooden butt being the metal portion kept inside a wooden cover from the possession of Md. Bappa which was carrying on his right hand.

2] One iron claw bar measuring 19 inch (approx), from the possession of Nandu Tirkey which was

3] One metal made knife measuring about 11 inch (approx) including wooden butt from the possession of Raja Basfore which was kept on his right hand.

4] One metal made Rambo Knife measuring 07 inch (approx) including wooden handle from the possession of Sujit Lama @ Tapa which was kept concealed on his back side.

I, ASI- Debasish Das S/O Haripada Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. Raja, Md.Ansar, Daiju, Bishal Routh, Bulla and others to the effect that today on 22.12.2023 at 00.10 hrs received a source information that 12/14 youths have assembled at Jorapani Bridge near Railway Line with a view to commit dacoity in a house at Uttar Bharat Nagar area. The fact was diarized in GD vide Siliguri PS GDE No- 1252, dated 22.12.2023. Subsequently after sharing the information with I/C Siliguri PS and as per his direction, myself along with ASI- Subir Sen, C/384 Biswanath Barman and C/1199 Mantu Debnath left for the place to work out the information. On way I contact ASI Sailesh Rai who was performing k-21 Van to accompany us to work-out the information. We reached at Fuleswari Rail gate at 00.55 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from Jorapani Bridge near Railway Line and seeing police personnel they tried to flee away from the spot but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they were assembled there to commit dacoity in a house at Uttar Bharat Nagar area with the leadership of Sujit Lama @ Tapa.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.05 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

Accordingly brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Uttar Bharat Nagar area. It is also revealed from them that (1) Raja, (2) Md. Ansar, (3) Daiju, (4) Bishal Routh (5) Bulla and some others have been assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Md. Bappa (M/22), S/O- Md. Rafiqul of Tikiya Para, Prankrishna Colony, W/No - 28, PS. Siliguri, Dist. Darjeeling, (2) Nandu Tirkey (M/25), S/O- Sri Saharai Tirkey of Bagrakote, Chittyaranjan Colony, W/No - 20, PS. Siliguri, Dist. Darjeeling (3) Raja Basfore(32yrs) S/o-Lt. Dinesh Basfore of Tikiapara, Ahmedkar Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling, and (4) Sujit Lama @ Tapa (M/22), S/O- Lt. Sankar Lama of Madanibazar, Baribhasha, PS. NJP, Dist. Jalpaiguri (5) Raja, (6) Md. Ansar, (7) Daiju, (8) Bishal Routh, (9) Bulla, and others and arrange for its investigation.
