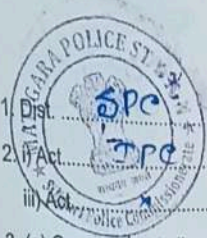

I, SMT. MILAN SARKAR, wife of Shyamananda Sarkar, resident of Vill. Kawakhali, P.O. Sushrutnagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that as follows:-

1. That SHYAMANANDA SARKAR, son of Late Karna Dhar Sarkar, is my legally married husband. A Hindu marriage was solemnized between me and my husband 32 years ago and out of our wed-lock one Male child nameiy Suman Sarkar (aged about 30 years) and one female child namely Susmita Biswas, wife of Sri. Avik Biswas (aged about 26 years) took birth.
2. That since our marriage my above named husband use to torture me and my children both physically and mentally. Initially he use to work as a labour in one motor vehicle engineering work shop but he neither use to spend his income for the development of his family nor even felt to fulfill our basic needs of life. He spends his entire income in drinking alcohol and in gambling. Whenever I ask him to change his nature and character he becomes furious and starts to assault me with fists, kicks and blows on my person. He unnecessarily slanders me with slang, filthy and offensive languages in front of my children and neighbours. I and my children tried to change his nature and character all these years but in vain.
3. That since five years he has stopped working. He has fully indulge himself in gambling and drinking alcohol. Few months ago he clandestinely sold of most of my golden jewellery and our movable properties. I came to know that one RATAN SARKAR, son of "unknown", resident of Vill. Patiramjote, P.O. & P.S. Matigara, Dist. Darjeeling (mobile No. 8101486901) who is the brother-in-law of my husband is trying to take the possession of our house from my husband in return said RATAN SARKAR shall pay my husband a lumpsum amount without my consent.

4. That on 22.12.2023 at about 05.30 P.M. said RATAN SARKAR arrived our house and said to me and my son in the presence of my husband that "your husband has sold his house to me. You and your son get out of this house right now. When I asked about this fact to my husband he agreed and threatened me and my son to evict his house otherwise he will kill me and my son. When I said to my husband that I shall lodge a written complaint against you to police he became furious and started to assault me and my son with bamboo. On our shouting my neighbours rescued us from his hands. My husband and said RATAN SARKAR before going out of our house they threatened me and my son that "if, within 24 hours, we do not leaving this house than they will kill me us by pouring kerosene oil"

I, therefore, request you to kindly take necessary legal steps against my husband and said RATAN SARKAR and thus oblized.
