I, SMT MILA SAHANI, Wife of Sri Munna Sahani, resident of Sahani Busty, Munsi Premchand Road, Prakash Nagar, Ward No. 43 of S.M.C., P.S. Bhaktinagar, Dist. Jalpaiguri beg to state as follows :-

On 20-12-23 at around 8 PM when I, myself along with my mother namely Dukhini Sahani, Wife of Late Jailal Sahani, my younger sister's son namely Sohan Sahani were at home. Our neighbours namely 1) Dharmender Sahani, 2) Jitender Sahani, both are sons of Joginder Sahani, 3) Dipak Sahani, Son of Upender Sahani, 4) Priyanka Sahani, Daughter of Joginder Sahani, 5) Urmila Sahani, Wife of Joginder Sahani and their associates, all are residents of Sahani Busty, Munsi Premchand Road, Prakash Nagar, Ward No. 43 of S.M.C., P.S. Bhaktinagar, Dist. Jalpaiguri without any permission trespassed in our house and on my query about their arrival like such manner, without spending any word, the above neighbours and their associates having wooden deadly sticks started to beat me mercilessly and on protest by my said mother and sister's son, they had also been attacked by them. It is right place to mention here that during such assault, the male personnel had intentionally outraged my modesty by pulling my wearing apparel as well as putting hands on my private parts and also they took cash from the house as kept inside the room worth Rs. 7,600/-(Rupees Seven Thousand Six Hundred) only, snatched the gold ear rings of my said mother. Thereafter on our shouting they left the place with a threatening of dire consequences. It is to be referred that on their leave, they uprooted the boundary tin barricades of our house. Out of their said attack, I along with my mother, sister's son received several bodily injuries and immediately our other family members took us to the Siliguri Dist. Hospital wherein We were treated. Out of mental trauma and tension, the delay caused to lodge this present complaint and now under stable mental position I have filed the present case.

It is therefore requested to your very end for treat this present complaint as specific case under strict penal provisions against the above 1) Dharmender Sahani, 2) Jitender Sahani, 3) Dipak Sahani, 4) Priyanka Sahani, 5) Urmila Sahani and do the needful for the better administration of Justice.
