Purna Singha Vill. Baro Lachka, PO-New Rangia, P.S. Matigara, Dist Darjeeling consumer under our office having Service Consumer ID. 412153464 has committed an offence under section 135(1)(a) of Electricity Act 2003 (Amendment Act 2007) as stated here under.

On 23/12/2023 at about 04:31pm Srl Subhendu Chowdhury, S/O Lt. Shardendu Chowdhury, Station Manager, Shibmandir Customer Care Centre, Himasgshu Roy S/O and other representative of WBSEDCL entered the premises of Sri Sajen Singha S/O- Lt. Purna Singha having consumer ID 412153464 to Inspect the electric installation and metering system. During inspection it was found that Sri Sajen Singha was illegally enjoying electricity for commercial purpose by means of service line tapping. The electrical load found in the premises of Sri Sajen Singha during inspection was 400 watt. The findings have been incorporated in the inspection report prepared by Sri Subhendu Chowdhury, Station Manager Shibmandir CCC WBSEDCL in presence of Sri Sajen Singha and the witnesses.
