Also in the light of the precius incidents it would be impertinant to bring this incident to light that on the day of 22.12.2023 that when I was Continuing the cractretion was they have hacked me and also inforted the police to stop the wall.

Therefore, i humbly request you to kindly take action as per law against the above mentioned persons.
