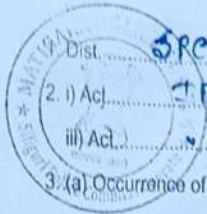

Sir I have purchased a piece and parcel of land measuring 2 katha by virtue of Deed of Transfer of Possession in the year 2022 by the hardened earned money from the possession of Sri Baban Roy, S/o Dhum Roy, resident of Ujanu Shiv Nagar, Near Darjeeling More, P.O Pradhan Nagar, P.S Matigara, Dist-Darjeeling,

Sir, since the date of purchase i along with my husband are residing at the same plot of land after constructing a house, but the above mentioned persons are continuously harassing me and my husband on each and every day. They consume Alcohol and other intoxicants near my gate and when i request them, the above mentioned persons abuse me with filthy languages.

Sir, it is to be mentioned here that on multiple occasions they have extorted money from me and my husband by putting us in fear and they have further threatened us with dire consequences and warned us to not to disclose the fact to anyone.

Sir, it is to be mentioned here that i am a very poor lady and my husband runs tea stall near Darjeeling more and we

are dependent on the small income from the said tea stall but the above mentioned Sanjay Ray and Ajay Ray forcefully enter into my house on several occasions and they outraged my modesty whenever they find me alone in the house.

Sir, the above mentioned persons are very dangerous and desperate persons and they have threatened us to leave the locality and they have very good relations with the antisocials elements and they will not hesitate to destroy my life.


Sir, yesterday i.e. on 24.11.2023 at about 10:00 PM at night the above mentioned persons came to my house and forcefully entered into the my house and hold me from back side and threatened us to leave the locality otherwise they will not hesitate to kill us.

Also in the light of the precious incidents it would be impertinent to bring this incident to light that on the day of 22.12.2023 that when i was continuing the cractretion was they have hacked me .and also inforted the police to stop the wall.

Therefore, i humbly request you to kindly take action as per law against the above mentioned persons.
