In producing herewith one accused person namely Ajay Chauhan @ Mocchu (25) S/O Lt. Shib Deb Chauhan of Baniakhari, Tripalijote, P.O. Nemai, P.S. Matigara, Dist. Darjeeling (not verified) in custody and the following property under seizure along with seizure list:-

1. Twenty (20) pieces of vials of NRX Buprenorphine Injection LUPIGESIC composition with Buprenorphine Hydrochloride 1P equivalent to Buprenorphine 0.3 mg each vials containing 02 ML (Total 40ML) and Marked as "Exhibit-A" kept inside one cartoon box.
2. Twenty (20) pieces of vials of RX Promethazine Hydrochloride Injection IP PHENERGAN Injection which composition with hydrochloride 1P 25mg each vials containing 02 ML (Total 40ML) and Marked as "Exhibit-B" which was kept inside one cartoon box.
3. Twenty (20) pieces of vials of NRX DIAZEPAM Injection composition with Diazepam 1P 5mg each vials containing 02 ML (total 40ML) and Marked as "Exhibit-C" which was kept inside one cartoon box.
4. One red Colour carry bag along with one white colour cartoon box where "Exhibit A" "Exhibit B" and "Exhibit C" were kept inside it and marked as "Exhibit D".

I, SI Biswajit Sarkar of Matigara PS/ SPC do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 24/12/2023 at about 14:45 hours received a secret source information that one person is possessing huge quantity of narcotic substance and is waiting for his customer near Lalpool bridge Himul under Matigara PS to deliver the same for his wrongful gain.

Accordingly the information was diarized vide Matigara PS/SPC GDE No. 1272 Dated. 24/12/2023 and informed the matter with a written letter to the Officer In-charge of Matigara PS, SPC.

As per kind order of Officer In charge of Matigara PS/SPC I along with SI Agen Lepcha, SI Sailesh Subba, ASI Pema Dorjee Sherpa, C/ 868 Sujal Roy, and C/219 Sanatan Chitrakar all of Matigara PS/SPC left Lalpool bridge by govt. vehicle vide Matigara PS/SPC M.C.C No- 2267/23 Dt. 24/12/2023 to verify the veracity of information. This refers to Matigara PS/SPC, GDE.NO. 1273, Dated. 24/12/2023.

At the time of departure from PS I took digital weighing machine, envelope, white paper, sealing wax, gum, seal and other investigation kits as it would be needed if any contraband substance was found.

At about 15:20 hrs I along with the accompanied team reached at Laalpool bridge and parked the vehicle at considerable distance. After reaching there I called two disinterested witnesses namely (i) Arun Kanti Nag (58) S/O Amarendra Nag of Ghogljote, PO- Matigara, PS Matigara, Dist- Darjeeling and (ii) Lalbabu Sahani (35) S/O Lt. Hira Sahani of Baniakhari Tripalijote, PO-Nemai, PS Matigara, Dist. Darjeeling and disclosed our identity as police officers of Matigara PS as well as the matter regarding our information and requested them to remain there as witnesses if any search and seizure be made to which they agreed.

I, also requested videographer namely Somnath Chatterjee s/o Sushil Chatterjee of Aurobindo Nagar, Ward No 22, PS Siliguri, over his mobile phone to come at the spot with his video camera and record the entire process of search and seizure

At about 15:45 hours as identified and shown by source I managed to apprehend one person who was carrying one red colour carry bag in his left hand near who was waiting for his customer. I, disclosed my identity as Police Officer and the accompanied team as Police team of Matigara PS to the apprehended person. On being asked he disclosed his identity as Ajay Chauhan @ Mocchu (25) S/O Lt. Shib Deb Chauhan of Baniakhari, Tripalijote, P.O. Nemai, P.S. Matigara, Dist. Darjeeling.

I, interrogate the apprehended person and shared the information about the possession of Narcotics Substances in his possession but he denied having such type of substances in his possession. But I told him that we would search him and his carry bag. Eventually he admitted that he had in his possession narcotic substances and was waiting for this customer to deliver the same. On thorough interrogation he disclosed that he is in possession of huge quantity of Narcotic Substances. Accordingly we detained the said person with strong reason to believe that he is illegally carrying Narcotics Substances for delivering the same to his customers for his wrongful gain.

Then I served him notice in written whether he wanted to be search in presence of an Executive Magistrate or any Gazetted Officer to which he agreed to be search in presence of anyone. I, also offered independent witnesses and detained person to search our Police team as per provision. But they refused to search the police team.

I then sent ASI Pema Dorjee Sherpa with a requisition to Special Executive Magistrate, Shri Manish Kumar Yadav, ACP (Investigation Unit) SPC, requesting him to come to the spot for supervising the process of search and seizure.

At around 16:30 hours, ASI Pema Dorjee Sherpa returned at the spot along with Special Executive Magistrate, Shri Manish Yadav ACP (Investigation Unit) SPC. As per provision of NDPS Act Shri Manish Kumar Yadav disclosed his identity as Special Executive Magistrate to the detained person as well as the independent witnesses telling him that he would be supervising the process of search and seizure.

As instructed by Ld. Special Executive Magistrate and under his supervision in presence of two independent public witnesses, search was conducted of the detained person observing all formalities and recovered above noted contraband articles:

SP Biswanil Senker,

On being asked by Special Executive Magistrate he was unable to produce any document/license in support of that 'Narcotic Substances' that was in his possession. He also confessed that he along with his associates has procured Narcotic Substance from Siliguri area to sell the same for their illegal gain. He also stated that he was carrying this business illegally since long and used to sell it to his customers and today he was waiting for his customer when the police team reached at the spot.

As instructed by Special Executive Magistrate I, seized all the above recovered articles under proper seizure list in presence of the above noted independent witnesses and the accused person, duly signed by the witnesses and the accused person on the seizure list. I labeled and sealed all the seized articles as 'Exhibit-A', 'Exhibit-B', 'Exhibit-C', and 'Exhibit-D' in presence of Special Executive Magistrate, independent witnesses and the accused person. The seizure and label was made in between 16:45. hr to 17:25 hrs. The whole process of search and seizure was video graphed by the videographer.

I, then arrested the detained accused person Ajay Chauhan @ Mocchu (25) S/O Lt. Shib Deb Chauhan of Baniakhari, Tripalijote, P.O. Nema, P.S. Matigara, Dist. Darjeeling (not verified) under proper Memo of Arrest for violating the terms and condition of the NDPS Act, after observing all guidelines of Apex Court and ground of arrest was duly communicated to him.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the accused persons named Ajay Chauhan @ Mocchu (25) S/O Lt. Shib Deb Chauhan of Baniakhari, Tripalijote, P.O. Nema, P.S. Matigara, Dist. Darjeeling and others and arrange for its investigation.
